WELCOME!

Norwegian Cruise Line enthusiastically welcomes families and teens on board our ships, and has designed a special program to make this cruise an enjoyable experience for the entire family. To give parents those needed moments alone and at the same time let them know that their children are not only having fun but are safe, we have put together a highly trained staff, each of whom is certified in CPR and first aid, so your child will be safe and secure at all times.

Every day, teens ages 13 to 17 can participate in activities designed especially for them. We know they're not kids anymore, so we've designed activities that are active, energetic and most important, fun. They and their fellow teens will be able to enjoy a variety of activities prepared by our Teen Counselors.

PROGRAM REQUIREMENTS:

- Parents(s)/guardian(s) must complete the one-time registration form for teens 13 to 17 years of age. Once this form is on file, teens are free to participate as often as they like!
- Teens are grouped together by age at time of sailing. Sorry, no exceptions - unless they celebrate a birthday during the cruise, of course!
- Teenagers must sign themselves in and out each time they join the teen group for activities.
- We ask that teens show up no later than 15 minutes after the start of their chosen activity. If that activity has been canceled, they are welcome to meet at the next activity.
- Teens with any symptoms of illness may be required to be evaluated at the medical center before being admitted to the Teen Program.
- Activities are flexible and subject to change based on participants.
- Teens are responsible for any personal items brought to activities and events.
- Teens are not permitted to smoke, consume alcohol or use profanity when attending activities and events.
- Parent(s) or guardian(s) will be financially responsible for any damage to property of Norwegian Cruise Line caused by their child(ren) on board the vessel. Public areas are under 24-hour surveillance.

SAFETY:

In the unlikely event of an emergency during program hours, teens will proceed directly to their emergency station. Parents should ensure that their children are familiar with their emergency station number or letter so they will know where to go.

INTERNET:

For your convenience we have 24-hour Internet service available in the Internet Café. Here you can email, chat online with your friends at home, access your AOL account and surf the Net. Basic time charge is .75 per minute. See the Internet Manager for the great plans we have to offer.

Parents: If you do not wish your child to have Internet access, please see the Internet Café Manager to deactivate your child's account.

NCL'S TEEN CREW

Welcome to the M/S Norwegian Spirit, teenagers! We have a fantastic week planned for you! Our Teen Program is designed to help teens, ages 13 -17, meet other teens! If you have any questions, please see the Youth Program Supervisor.

- Activities are flexible and subject to change, based on participants.
- For time, or location changes, please check with the reception desk on deck 7, mid ship.
- If no teens show within the first fifteen minutes of a scheduled activity, the activity is then cancelled, and Teens will meet at the next scheduled time.
- Teens with any symptoms of illness may be required to see the medical center before being admitted to the program.
- When registering a teen for the program, guardians must advise of any allergies, medications, or special needs, of their teen.
- All Teens are responsible for any personal items brought to activities and events.
- Youth Staff is not included in onboard gratuities.
- NCL strongly encourages that no teenagers go ashore alone in the ports of call.

SHIP'S RULES AND GUIDELINES

- No running is allowed in any of the public areas onboard the ship at anytime.
- Jumping in the pools or hot tubs is strictly prohibited.
- Guests must be 16 years of age to use the fitness facilities.
- No one under the age of 18 years is allowed in the nightclubs or lounges after 11:00 pm.
- No one under the age of 18 years is allowed in the Casino at any time.
- Please respect the property of Norwegian Cruise Line. If you are caught in the act of vandalism, you will be held accountable for the damages.

TEEN PASSPORT PROGRAM

The Teen Passports have been designed as a non-alcoholic beverage program for anyone ages 13-17. For \$34.50, including gratuity, Teens get a booklet containing 20 coupons, each good for 1 non-alcoholic beverage at any of the ships' restaurants and bars. There are also special parties for Teen Passport holders registered in the Teen Program throughout the voyage. Please note that Teen Passports are not replaceable if lost. Please see a member of your friendly Bar Staff anytime throughout the voyage if interested in this great value!

TEEN PROGRAM DISCIPLINE POLICY

Teenagers are prohibited from smoking, drinking alcohol, and using profanity while attending Teen activities. Violence and Vandalism will also not be tolerated under any circumstances. Should a teen behave inappropriately at a scheduled Teen activity, they will be asked to correct their behavior immediately. If they do not follow the directive of the Youth Staff, they may be dismissed from an activity. Parents and the ships Security will then be notified. Any behavior reported to a member of the Youth Staff taking place outside Teen programs will also be reported to Security. All Teens should be advised that all public areas are under 24-hour surveillance.
